Rights and obligations

Membership

DES membership is entered into for an indefinite period.

Contribution

DES has a different contribution system for its various swimming branches.

The contribution is structured as follows:

All costs of the association such as bath rental etc. are added up over a year, this total is divided by 12 and divided by the average number of members. This means that a contribution is levied every month, even in the summer months when the regular training and lessons are canceled. Incidentally, there is always a swimming pool available where you can swim freely during the summer holidays, including close family members. Which pools are open for free swimming during the summer holidays can be read on the website in the summer months.

The contribution starts on the 1st day of the month in which you go swimming.

The membership fee for KNZB membership is collected annually in the month of January (or at the 1st direct debit for new members).

Administration costs for registering per new member: one-off € 10.00.

Contribution Ooievaarspas

DES grants a 100% discount on the membership fee for holders of an Ooievaarspas up to 18 years, holders of an Ooievaarspas aged 18 and older receive a 50% discount.

There is a maximum: up to 18 years a maximum discount of € 26 per month applies and for members aged 18 and older a maximum discount of € 13.00 per month

For athletes (competitive swimming and water polo) these amounts are € 27.50 and € 13.75 respectively.

PLEASE NOTE: if your Ooievaarspas is no longer valid, you must report this immediately to the member administration via ledenadministratie@zwemvereniging-des.nl or via the table in your swimming pool. The membership fee will have to be paid again through your own account after the expiry of your card, so please notify us in time to prevent payment arrears.

You must have the Ooievaarspas with you every time you visit the swimming pool. The Ooievaarspas must be shown weekly - on request.

Holders of the Ooievaarspas also receive a one-off administration fee of € 10.00 upon registration. The KNZB contribution is only reimbursed for 50% for *elementary swimmers*.

Considerations

Point of attention for elementary swimming and sports.

You can only swim for a diploma if all membership fees have been paid, including those of the current membership period. Paying on time is the responsibility of the parents and not of the membership administration.

At the start of the new contribution period, if payment has not yet been made, the arrears will be increased by the new contribution.

About within a week of the start of the subscription period, everyone who is behind will receive a reminder. There are costs associated with this. Per month arrears an amount of € 5 administration costs will be charged.

Members who are in arrears from the previous period will receive a letter two weeks after the expiry of the payment date of the reminder with the last payment option and the announcement that, if no payment is made, the swimming lessons, training, etc. will be stopped. After payment of the arrears, the treasurer will again grant permission to take the swimming lessons and / or training.

Only the treasurer can make agreements about a repayment arrangement.

All outstanding payment obligations remain in effect upon termination of the membership.

Becoming a member of another association affiliated with the KNZB can only take place if all obligations have been met.

Unsubscribe

Cancellation of membership only by e-mail: Ledenadministratie@zwemvereniging-des.nl.

You will always receive a confirmation email.

If you do not have e-mail, you can report this to our administrator at the table in the pool. You can then fill in a form "Cancellation membership" on the spot. You will then receive a "Proof of cancellation of membership". Please keep this carefully, so that - in the unlikely event that something goes wrong with the cancellation - you can submit this proof.

Please also take into account that DES has a notice period of 1 full calendar month according to the articles of association. This means that if you unsubscribe on 21 November, for example, the month of December will be the cancellation period. Membership will then end on January 1.

Your cancellation is equal to a cancellation of the authorization to direct debit of the contribution. You do not have to do this again separately.
